

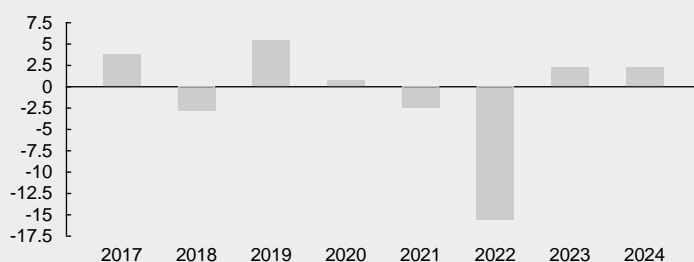

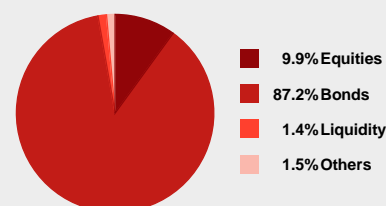
Investment Goal

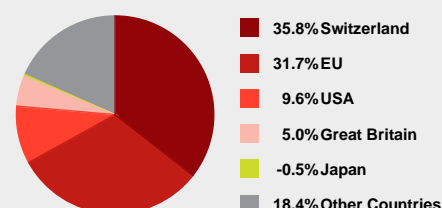

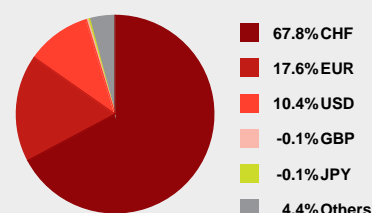
