

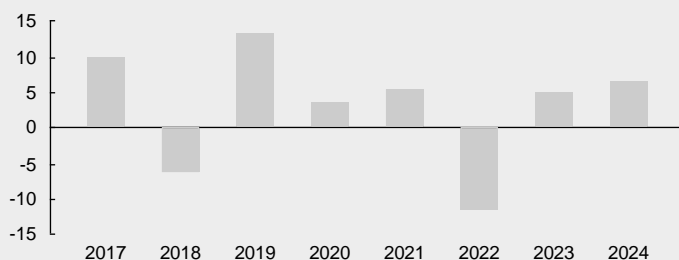

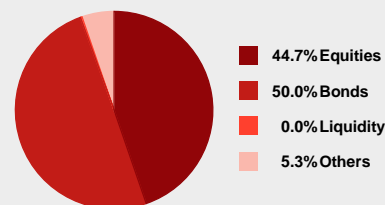
Investment Goal

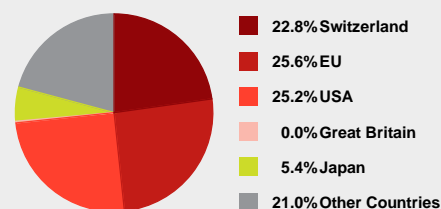

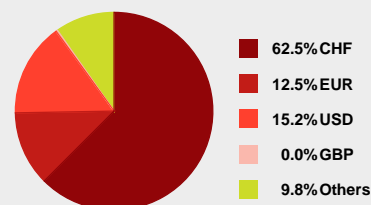
