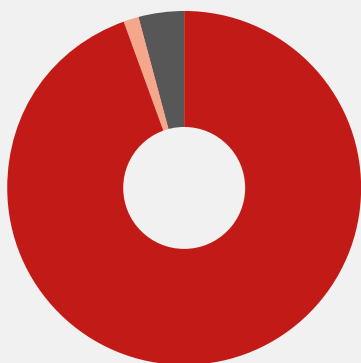

### Asset allocation



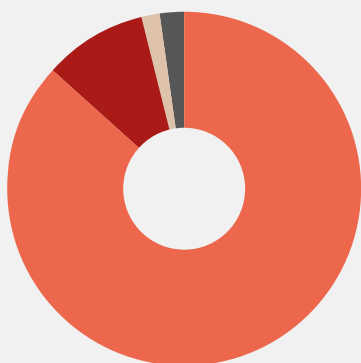
