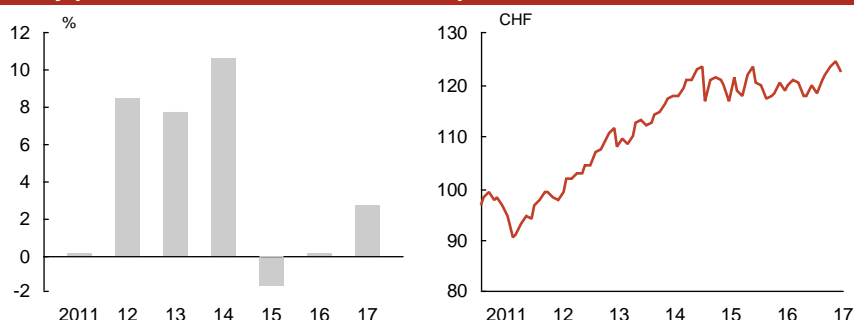
### Investment Goal

The investment is made worldwide in index funds. All index funds replicate a large liquid index as exactly as possible by investing in all securities contained in that index. The benchmark of the umbrella fund is based on the weighting of the single indices. Once a month the umbrella fund is rebalanced to realign the percentage weighting of the index funds. With a target equity component of 40%, the investment approach is balanced and favours CHF. The objective of this strategy is to grow assets significantly over the long term.

### Yearly performance in % / accumulated performance in CHF to 30.06.2017



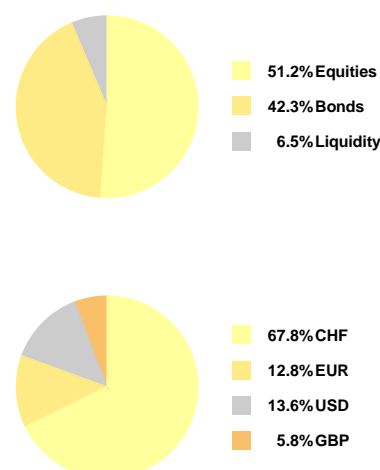

## Financial glossary

<b>Securities number:</b>	The identification number applied in Switzerland to securities to facilitate their trading and transfer. This is known as the ISIN at the international level.
<b>Benchmark:</b>	An index which serves as a basis for comparing the performance of an investment fund. The benchmark specifies a comparable/reference portfolio against which the performance of the portfolio in question can be evaluated. Benchmark returns do not contain cost components.
<b>Net asset value (NAV):</b>	The net asset value of a share is equal to the net fund assets divided by the number of outstanding shares.
<b>Modified duration:</b>	This is a measure of interest rate sensitivity. The modified duration indicates the percentage change in a bond's price when the market interest rate changes by 1%. The percentage change of the bond is calculated by multiplying the modified duration by the percentage change in the interest rate. It is the ratio used by investors to assess all pricing opportunities and risks at a glance.
<b>Average remaining maturity:</b>	The bonds' average remaining life from the current date to maturity or early redemption, as the case may be. This figure indicates the term – shorter or longer – of the fund's investment.
<b>Issuing commission:</b>	The commission charged by the issuing fund company to the investor on the purchase of fund units.
<b>Flat fee:</b>	Calculable figure charged to the fund's assets arising from the fund's operations. This commission covers all expenses incurred in the purchasing, selling and safekeeping of securities as well as all sundry costs (for printing prospectuses and annual/semi-annual reports; auditing and publishing prices; fees charged by the supervisory authority; etc). The only costs not covered are those incurred in the purchasing and selling of securities through the fund manager.
<b>Total expense ratio (TER):</b>	This is a standard ratio making funds more directly comparable and gives information on the annual fees and expenses associated with an investment fund on top of the issuing commission.
