The innovative service modules for debt collection and advisory legal protection offer the perfect means of complementing any of the modules.

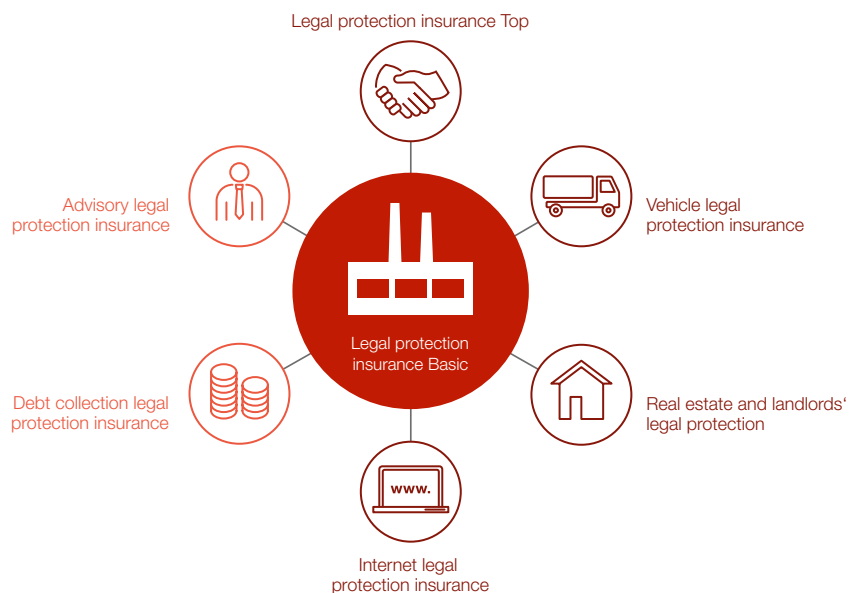

Detailed overview of modules:

BASIC MODULE

Corporate legal protection Basic

Provides insurance for disputes arising in the course of everyday internal operations and covered by central branches of law.

- Solid basic cover for every company.
 - Worldwide insurance coverage.
 - The costs of lawyer's fees, expert opinions and court proceedings are covered up to a value of CHF 1 000 000.– per case.

MODULES FOR SPECIFIC AREAS

Corporate legal protection Top – NEW

Provides insurance for disputes with customers, suppliers, service providers and competitors.

- For all companies that want to protect themselves against legal and financial risks in disputes with customers and suppliers.
 - Offers extensive contract law protection and provides insurance for areas of intellectual property law and tax law.
 - Complements the Basic module perfectly with comprehensive worldwide contract law cover.

Vehicle legal protection

Provides insurance for disputes in connection with vehicles and road traffic incidents.

Real estate and landlords' legal protection

SERVICE MODULES

Debt collection legal protection – NEW

Provides insurance for the collection of undisputed debts that are not subject to the statute of limitations, and includes 15 credit assessments.

This module provides the insured company with extensive, customised legal advice in all legal matters.

Fortuna COMPLETE im Überblick

How long does the insurance cover apply for?	The insurance cover applies (after a waiting period of 60 days from the beginning of the contract) to legal cases that occur and are reported to Fortuna during the term of the insurance contract.
Where does the insurance cover apply?	Depending on the module and insured risk, the insurance cover applies in Switzerland and to some extent also in the Principality of Liechtenstein, Europe and the rest of the world.
Who is insured?	The company and the operating activities of the co-insured companies and subsidiaries listed in the policy.
How is the premium calculated?	The premium depends on a company's business activities, revenue, payroll and number of the employees.
