He gained his MBA at the Booth School of Business of the University of Chicago. Alexander Lacher is co-author of the Basler Kommentar on the Swiss Insurance Supervision Act and regularly publishes articles on the subject of insurance law. Alexander Lacher is also a lecturer at the Zurich University of Applied Sciences (ZHAW) in compliance and labour law.
